Terms and Conditions of Use

1. Should payment for a tradesman's waiver be dishonoured the season ticket will be invalid
2. A tradesman's waiver must be displayed prominently in the front windscreen of the vehicle for it to be valid. You are advised to adequately secure the waiver to your windscreen or on top of the dashboard. Failure to display the waiver may result in a Penalty Charge Notice being issued.
3. The vehicle must be essential on site and need to be continuously accessed.
4. The council may refuse or restrict issue of a waiver at its discretion.
5. A waiver is only valid for the vehicle for which it is issued. A waiver is not transferrable to any other vehicle, location or date.
6. A permit is not guaranteed for the location requested. If the requested location is not approved an alternative location may be offered.
7. A waiver does not guarantee a space in the stated location.
8. If the vehicle is seen to causing an obstruction to the flow of traffic, access or a pedestrian route, the driver may be asked to move the vehicle to another location.
