Notice of adoption of the Wiltshire Core Strategy Development Plan Document**

Notice is hereby given in accordance with Regulations 26 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012, that the Wiltshire Core Strategy Development Plan Document ('the Plan') was formally adopted by Wiltshire Council on 20 January 2015.

The Plan provides a positive and flexible overarching planning policy framework for Wiltshire for the period up to 2026. Now adopted, the Plan forms part of the development plan for Wiltshire.

The Plan was the subject of an independent examination conducted by an Inspector appointed by the Secretary of State. The Inspector's Report was published in December 2014 and the recommended main modifications have been included in the adopted plan.
