South Wiltshire Core Strategy Examination

I write following the Programme Officer's letter, dated 7 June 2010, seeking comments on whether the intended abolition of the emerging SWRSS impacts on the soundness of the Core Strategy.

Blonefield Property Company's interest in the Core Strategy relates to Core Policy 9, Old Sarum Airfield. This seeks to provide a policy framework within which lasting solutions to problems associated with development and use of the historic site can be achieved and is framed such that the potential for development on the airfield should be considered on its individual merits against the criteria established by the policy.
