## £50million for inspired facilities



Sport England has today launched a £50million programme to refurbish and improve up to 1000 community sports clubs.

The **Inspired Facilities** fund is part of the **Places People Play** legacy programme that is bringing the magic of a home Olympic and Paralympic Games into communities across the country.

Investment will be available to breathe new life into tired facilities that can be unattractive to sports participants, expensive to run and difficult to maintain, putting these clubs right back at the heart of their local communities. There will also be money available to convert existing buildings into venues that are suitable for grassroots sport.



### Typical investments might be:

- A sprung floor that converts an unused hall into a local multi-sport facility
- New changing rooms, so away teams no longer need to change in the car park
- New floodlights that mean a facility can be used for many more hours of the day.

At least £35 million of the funding will go to community and voluntary organisations, through grants of between £20,000 and £50,000. The remaining money will be open to a wider group of organisations, including councils and schools, with grants of up to £150,000 available.

Applicants whose project will benefit disadvantaged young people will also be invited to [apply for funding from the Thomas Cook's Children's Charity](#) from August this year.

## Cricklade – Best of the Best

---

Tuesday, 2 August, Cricklade steps up to the bar in Britain in Bloom's highest competitive category – Champion of Champions. In a total UK field of five, this pretty, historical town is only one of two finalists in the whole of England chosen to compete for this national title. Two RHS judges, Martyn Hird and Jeff Bates, will spend most of the morning touring the town taking note of the efforts made by the local community to bring the area to this outstanding level of achievement.



Among other fantastic efforts throughout the county, Cricklade leads Wiltshire in its success in the annual RHS competition. It has won the South West regional award four times and won the national title of Best Small Town in the UK in 2008 and was just inches away from winning it again in 2010. This is no easy feat as the Britain in Bloom contest is open to towns, villages and cities all over the UK, Channel Islands and Isle of Man. Competition is high with more than 1,000 communities taking part in 2010.

Cricklade Bloomers, the voluntary group spearheading this along with the town council, Wiltshire Council and other local groups and individuals have again worked tirelessly to clean up and green up the town. Last week nine separate Cricklade groups impressed visiting RHS assessors in the countrywide campaign – It's Your Neighbourhood.

Chair of Cricklade Bloomers, Anita Barratt said: "We are all so proud of what our town has achieved. It's not just about floral displays, the aim is also to engage with local communities to improve the environment we live in so it's sustainable planting and landscaping through to the dealing with litter and graffiti. Next week is the culmination of years of effort with lots of success along the way and to win Champion of Champions would be a fabulous achievement as Cricklade is representing not only Wiltshire but the whole of the south of England.

The judge's route includes a visit to the Community Garden and the town's famous National Nature Reserve, North Meadow, as well as the resplendent High Street and various residential areas. The judges and other guests including Jane Scott, Leader of Wiltshire Council, will join Cricklade Bloomers in their garden behind the town council offices for a short lunch. This will give them a chance to chat about the town including future plans around the creation of a gateway to Cricklade at the Eastern Roundabout at the A419 and the creation of a Heritage Trail with interpretation boards around Cricklade.

The winner of the competition will be announced at a ceremony at St Andrews, Scotland on Sunday, 25 September 2011.

## Innovative new housing scheme for Salisbury

---



An exciting new development, The Sidings and The Sleepers at Tollgate Road, Salisbury, has just been completed by Raglan Housing Association.

The design maximises the space available and offers 24 x two bed flats with underground parking, private and communal garden spaces plus cycle stores. Heating and hot water is provided by NIBE exhaust air heat pumps, which assisted in meeting Code for Sustainable Homes Level 3.

The scheme comprises a mixture of properties for general rent and for rent to buy which will help to address the demand for affordable housing in the Salisbury City area.

The Rent to Homebuy scheme is the first of its kind in South Wiltshire, and has proved to be very popular. It will enable applicants to rent a brand new home below market rent levels for up to five years, whilst saving for a deposit to eventually buy their home on a shared ownership basis. With house prices and rents at high levels in Salisbury, this is a welcomed initiative.

This development is another excellent example of what can be achieved through effective partnership working, with Raglan Housing Association, the building contractor, Parsons and Joyce, and officers from Wiltshire Council all working together to make this scheme the success that it is. Funding was also provided by the Homes and community Agency.

This scheme has been nominated for the Local Authority Building Control Building Excellence Awards by Paul Vignor, a Building Control Surveyor at Wiltshire Council. Paul says, "The interesting design, quality of build, and the excellent relationship between Building Control and the site management of this project would make it ideal for the LABC awards" The scheme will be nominated for the 2012 awards.

## Winter grit bin review

---

It has not been possible to provide any additional grit bins this year because of the difficulties we have had keeping the existing ones filled during severe weather when our operatives are busy driving snow ploughs and gritters.

However, there is an opportunity for parish and town councils to review their existing grit bins to ensure they are where they are needed most. If you want any of them moved to better locations let us know before the end of August and we will carry out the necessary site inspections.

The provision of one tonne bags of salt to parish councils was very successful last year. It enabled communities to fill their own grit bins, and we are repeating the scheme this year. It is necessary to have undercover storage for the salt in a suitable location, and be able to transfer the salt to where needed.

Any requests for one tonne bags of salt or relocation of grit bins must be submitted by the 31 August.

# History Centre officially one of the best

---



The Wiltshire and Swindon History Centre has been officially recognised as providing one of the best archive services in the country. It has been awarded a maximum four stars in a recent assessment by The National Archives, which acts as the government watchdog for archives. The History Centre, funded by Wiltshire Council and Swindon Borough Council, is listed in the top ten archives in England and Wales out of a total of 124 services across the country.

**Stuart Wheeler, Wiltshire Council Cabinet Member for Leisure, sport and Culture said:**

“Before the History Centre was built and opened in 2007, the National Archives told us that our facility for archives was not fit for purpose. Today, not only do we now have a modern state of the art History Centre, but also a service that is officially recognised as one of the best in the country and it confirms what our customers have been telling us. To reach this position in such a short space time, providing both excellence and value for money, is an outstanding achievement by everyone involved with the History Centre and Wiltshire is very proud of its Archive service.”

As well as considering the excellent facilities at the History Centre, the assessment looked at how the service performed during 2009-10, such as how it makes the wealth of material contained in over eight miles of archives available to family and local history researchers, at the History Centre, and through a service point in Swindon Central Library, material provided at Salisbury Library and online services, including over 200,000 downloadable images of Wiltshire wills; and high standards of customer care, notably a 100% successful score in a national customer survey.

It also recognised the centre’s exciting programmes of activities and events; its innovative partnerships with local communities and organisations, such as the Heritage Lottery funded SEEME Wiltshire Black History project; and pioneering work with schools and young people through a heritage education service that has been nationally recognised for its involvement as the south west regional champion for the British Library / MLA funded Campaign Make and Impact scheme. The service has been delivered to more than 21,000 customers, 10,000 remote enquiries and 300,000 online page views each year. ## Street trading scheme

---

Your attention is drawn to a short two week consultation on the final draft of the proposed harmonised Wiltshire Council street trade consent scheme. This scheme has been drawn up following an extensive 15 week consultation carried out at the beginning of 2011 and subsequent changes agreed at the Licensing Committee in May 2011.

The scheme will be presented to the licensing committee on the 7 September 2011 with a recommendation for adoption by council in November 2011. If adopted, the scheme will promote a fair and open approach to street trading across the county.

## Green Room

---



The new Wiltshire Warm and Well scheme has been set up by Wiltshire Council with the aim of improving the energy efficiency of properties by installing loft and cavity wall insulation. We will be actively promoting the scheme in several different ways and the Green Room is our latest tool in helping to reach residents throughout Wiltshire. The Green Room is a mobile advice centre that we have partially funded with the Warm and Well contractor, Domestic and General Insulation Ltd. It can be taken to both community and Local Authority events and shows, and members of the public can simply drop in for general energy efficiency advice as well as information on renewable technologies and how to apply for grants for

energy efficiency such as loft and cavity wall insulation, solid wall insulation and A-rated, fuel efficient heating systems.

The vehicle showcases several renewable technologies and there is a wide selection of literature and free energy saving gadgets that visitors can take advantage of whilst on board! # The Queen Elizabeth II Fields Challenge

---

The Queen Elizabeth II Fields Challenge is an exciting new programme to mark Her Majesty The Queen's Diamond Jubilee led by its Patron The Duke of Cambridge. It is a landmark project to create a permanent, tangible and relevant legacy from the two major events scheduled to occur in the UK in 2012; Queen Elizabeth II's Diamond Jubilee and the London 2012 Olympics.

The challenge will permanently protect a network of 2012 outdoor recreational spaces in communities across the UK by way of 'Deeds of Dedication' between the landowners and The National Playing Fields Association (operating as Fields in Trust).

All QEII Fields - whether sports pitches, children's play areas, woodlands, cycle trails, ornamental gardens or country parks - will be marked with a plaque provided by Fields in Trust. Additional benefits to town and parish councils and other landowners of taking part in the challenge include:

- Access to improvement grants (SITA Trust's £1 million QEII Fields Fund and Sport England's £10 million Protecting Playing Fields Fund are open to applications now. A new Fields in Trust Legacy Fund will also be launched later this year)
- Access to a resource pack to support local 'Have a Field Day' community events on outdoor recreation sites right across the UK to celebrate the Queen's Diamond Jubilee.

Fields in Trust are working hard to engage local authorities and town and parish councils across the country towards the target of 2102 QEII Fields by the end of 2012. Since Prince William launched the challenge last year, hundreds of nominations have been made for all kinds of outdoor spaces to be protected as Queen Elizabeth II Fields. The range of sites is brilliantly diverse – a coastal path in Kent, a nature reserve in central London and, here in Wiltshire and Swindon, an open space with facilities for children's play in the parish of Minety, a recreation field in Kington St Michael, a park, a play area and a community sports facility in the town of Calne to name but a few!

Fields in Trust are confident in attracting further nominations for outdoor recreation sites across the county with the support of Sport England SW, GreenSpace SW, Wiltshire & Swindon Active Sports Partnership (WASP), Community First and Wiltshire Association of Local Councils.

If you discover your local authority is not participating then download our call to action form from the website to encourage them to get involved.

Fields in Trust has been incredibly privileged to be supported in the Challenge by HRH The Duke of Cambridge over the past year. In April, The Duke and Duchess of Cambridge visited Witton Country Park in Blackburn on their last official engagement before their wedding. It was a fantastic event – despite the rain! – with thousands of people gathering to wish them well and watch the host of activities arranged on the playing field. The Duke of Cambridge then signed the Deed of Dedication for Witton Park which now has pride of place at Blackburn with Darwen Council. Outdoor spaces really do form the green hearts of our communities and this was a great opportunity to shine the spotlight on how important they are.



Other key supporters of the challenge include Fields in Trust's principal partner, ASDA and, in England and Wales, the law firm Freshfields Bruckhaus Deringer who provide pro bono support with the legal deeds. The Football Association, The Rugby Football Union, Rugby Football League, England & Wales Cricket Board and The Lawn Tennis Association are also actively backing the challenge.

## Rights of way maintenance update

### South

The parish maintenance programme has seen **Woodford** surveyed and the works will be completed soon. A longstanding surface repair in **Coombe Bissett** has been completed along with the PIGS (Path Improvement Grants) scheme in the parish. The Ministry of Defence will be providing and delivering chalk to a byway in **Tilshead** that has been severely damaged from motorised use. The rights of way team will top the repairs with planings once they become available.

### North



The parish maintenance programme has been completed at **Luckington** and **Nettleton** has been inspected to be visited next by the Maintenance Contractor. The Roman settlement at the Fosse Way at Whitewalls Avon crossing, **Easton Grey** is a significant Scheduled Monument considered to be of national importance. Wiltshire Council has a responsibility to protect, as far as possible, important archaeological sites from damage. There has been extensive abuse of the site particularly by 4x4 vehicular users driving in and out of the river, carving ruts and hollows into the surrounding land and in the process exposing and damaging the archaeological remains. The river at this location is of ecological importance, being a spawning ground for trout and a habitat for otters. To

resolve these problems, a temporary traffic regulation order has been made (with proposed permanent legal restrictions) preventing access to the full extent of the site by motor vehicles and to limit motorcycles and accompanied horses to the designated track. Gates and barriers have been installed to enforce the closure and limit access to the site.



### West

Surface work has been completed on a footpath at Wine Street in **Bradford on Avon**; the route is particularly steep so a resin bound surface has been used. A tarmac surface has also been completed on a footpath in **Holt** which leads to a primary school. Byways in **Upton Scudamore** have been resurfaced using planings. The parish maintenance programme has been completed in **Hilpertown** and **Semington** and **Trowbridge** have been surveyed and general maintenance works will begin shortly.

## East

Surface works have been completed on a byway at **Easterton** that had extremely bad ruts. The chalk and stone used to complete the works was provided by Wessex Water who are currently installing a pipe line in the area. Wessex Water even delivered the materials to site.

## Rights of way volunteers across the county

The South Wiltshire Ramblers Volunteer Working Party has completed the installation of a bridge on a footpath in **Landford** and a footpath in **Sedgehill**. Nick Cowen, Senior Rights of Way Warden for the area, the MOD and Tread Lightly has installed a large number of signs on byways on the plain to prevent confusion to the public about where the routes are. Tread Lightly is a voluntary motorised user organisation whose aim is to preserve access opportunities for all user groups and to help prevent illegal use by assisting with signage projects, patrols and promote legal use through effective education. Local parish working groups have also been working hard including **Tisbury volunteers** have completed some drainage work in the parish.



In the north the Cotswold Wardens have installed a bridge on a bridleway at **Colerne** and installed a gate in the parish of Ford.

The east/north Wiltshire Ramblers Volunteer Working Party will be resuming on 9 August and will be concentrating on projects such as improving the **White Horse Trail**. **Bishop Cannings** Rights of Way Volunteer Group has installed a 2 in 1 gate which they also paid for themselves.

The West Wiltshire Ramblers Working Group have installed a kissing gate in **Upton Scudamore** and cleared a footpath in **Studley Green, Trowbridge** that had featured in the Gazette and Herald, where the bridge steps have been improved and a handrail has been installed for safety. **North Bradley** parish council are sponsoring a kissing gate project around the village. Local residents are purchasing the gates to replace less accessible stiles and Ramblers Working Group is installing them. This project has been extremely successful in other parishes including **Corsley, Holt** and **Hilperton**.
