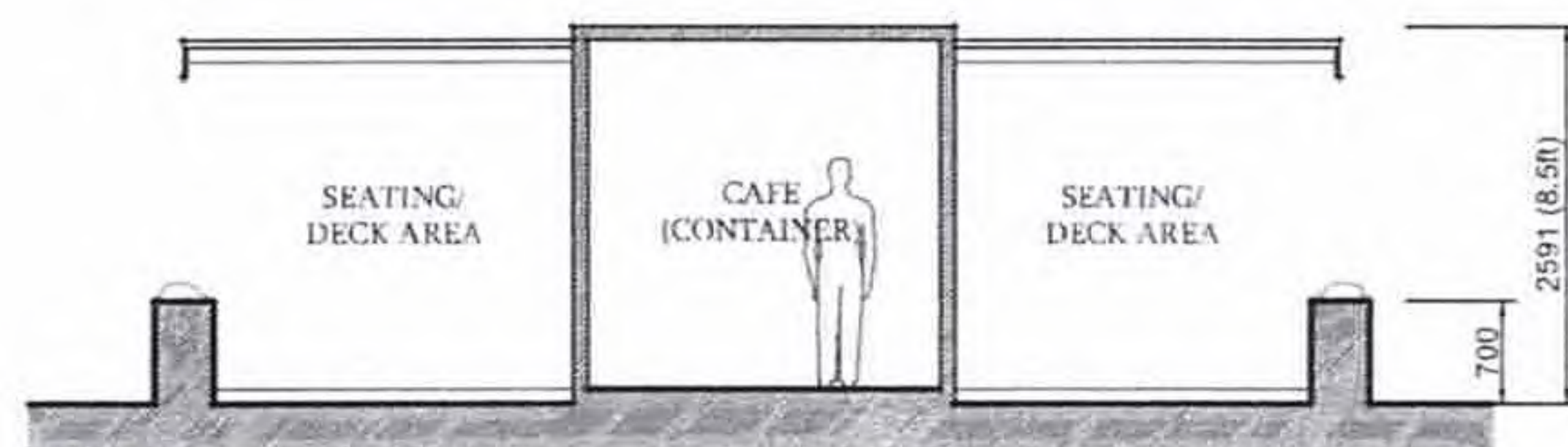

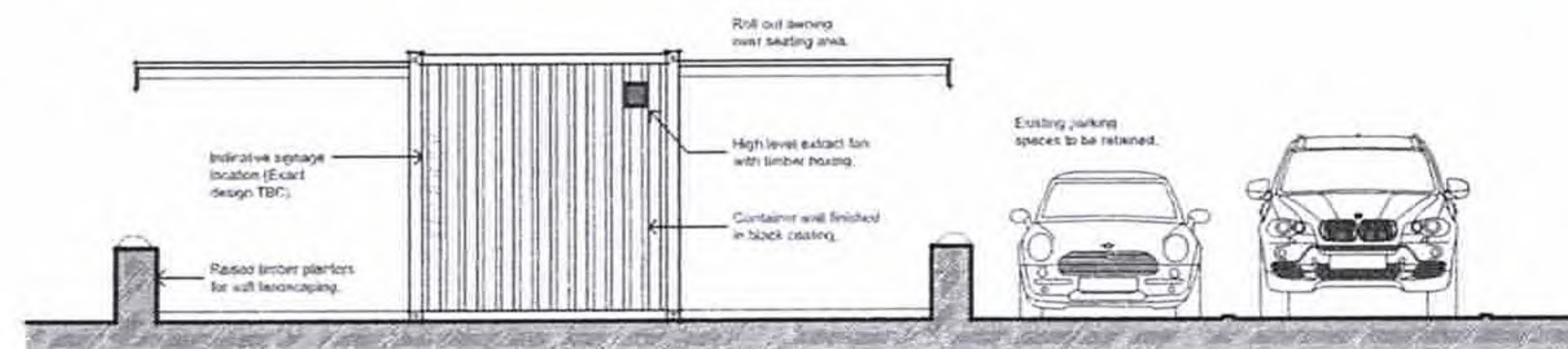

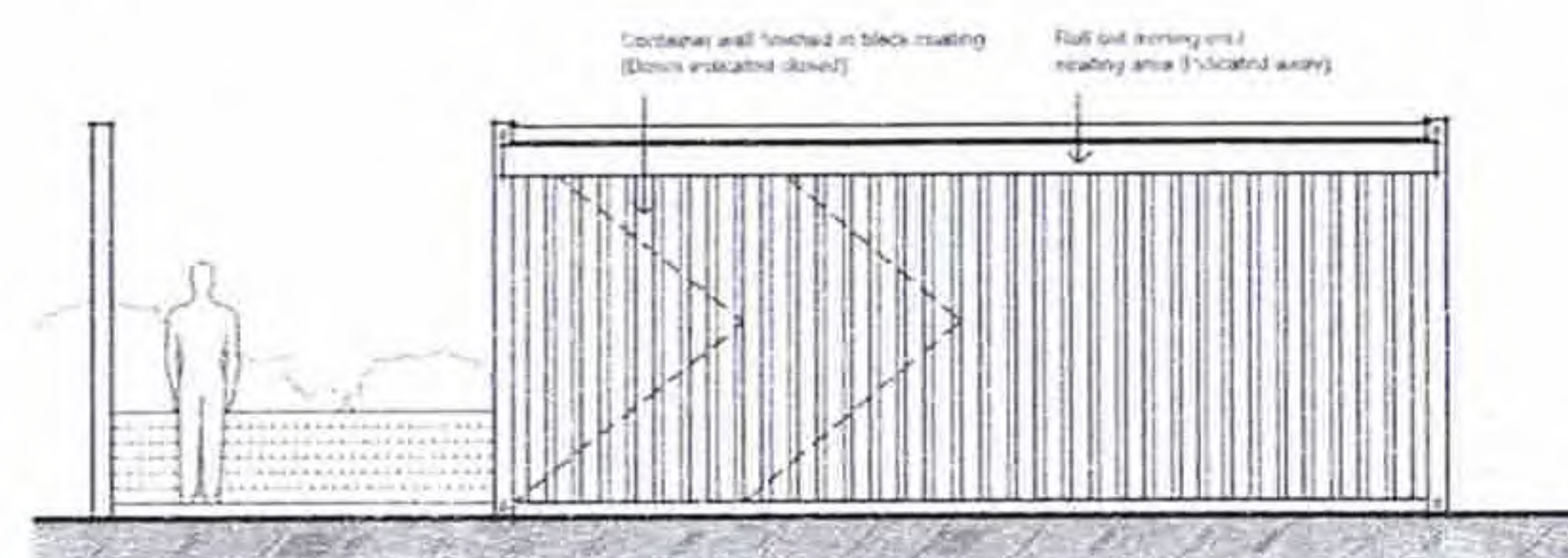
Proposed Section Scale 1:100 at A3



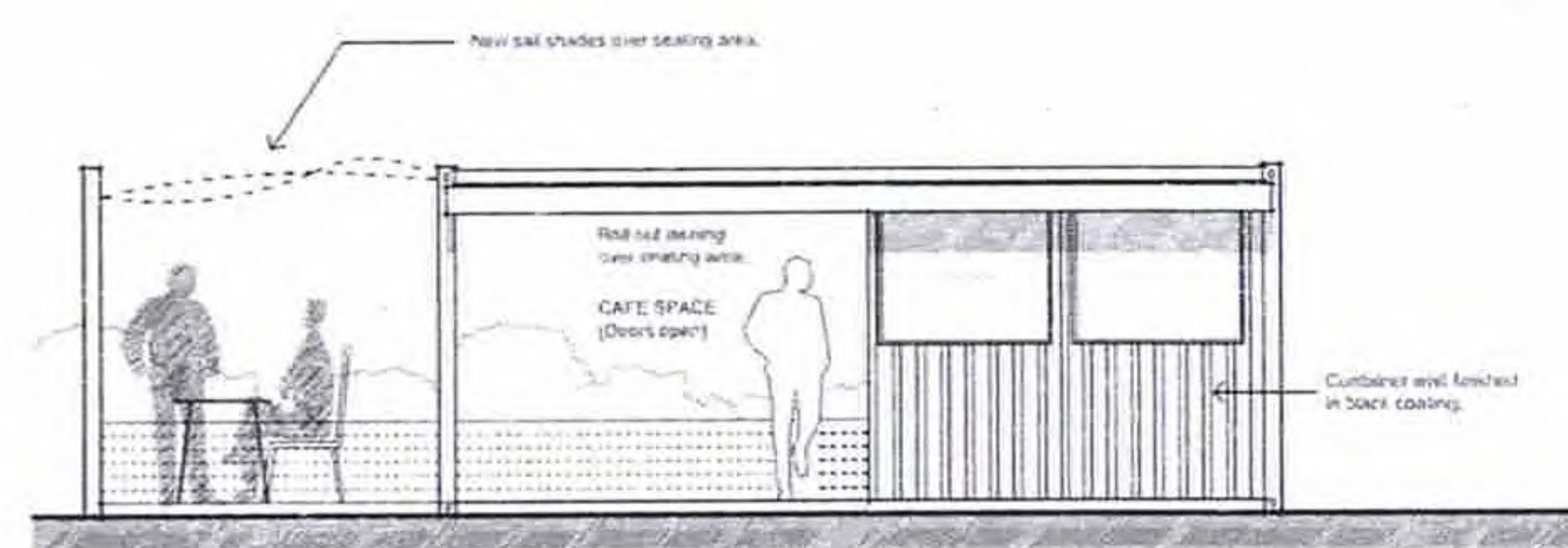
Proposed West Elevation Scale 1:100 at A3



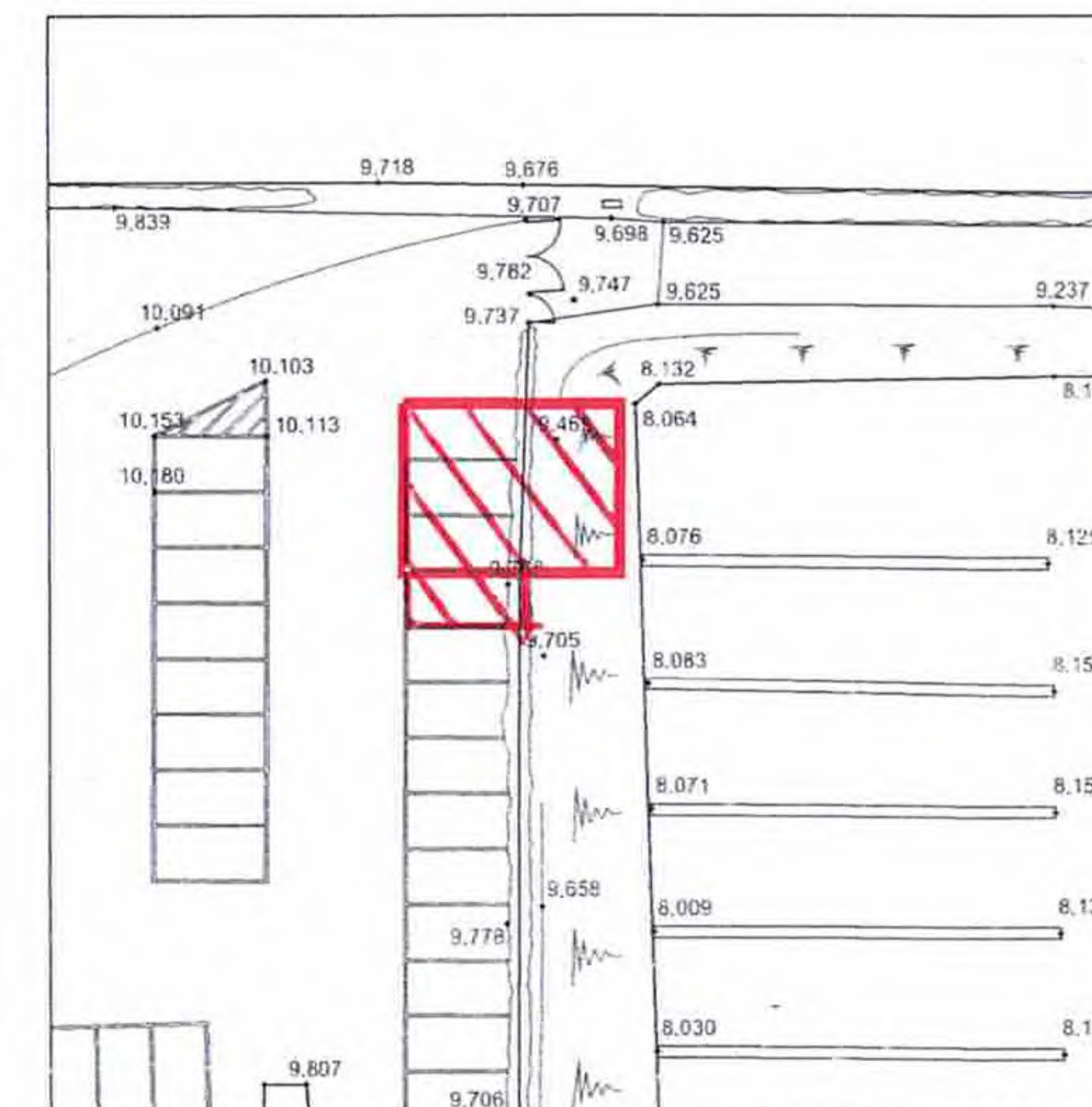
Proposed Floor Plan Scale 1:100 at A3



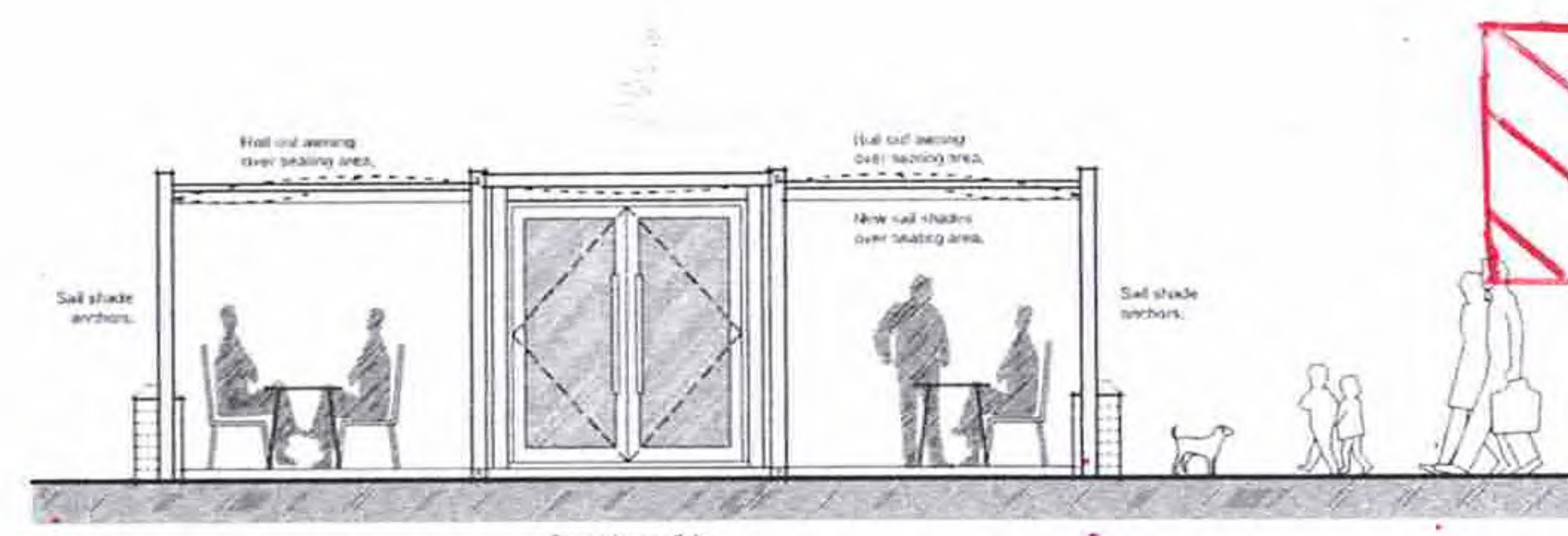
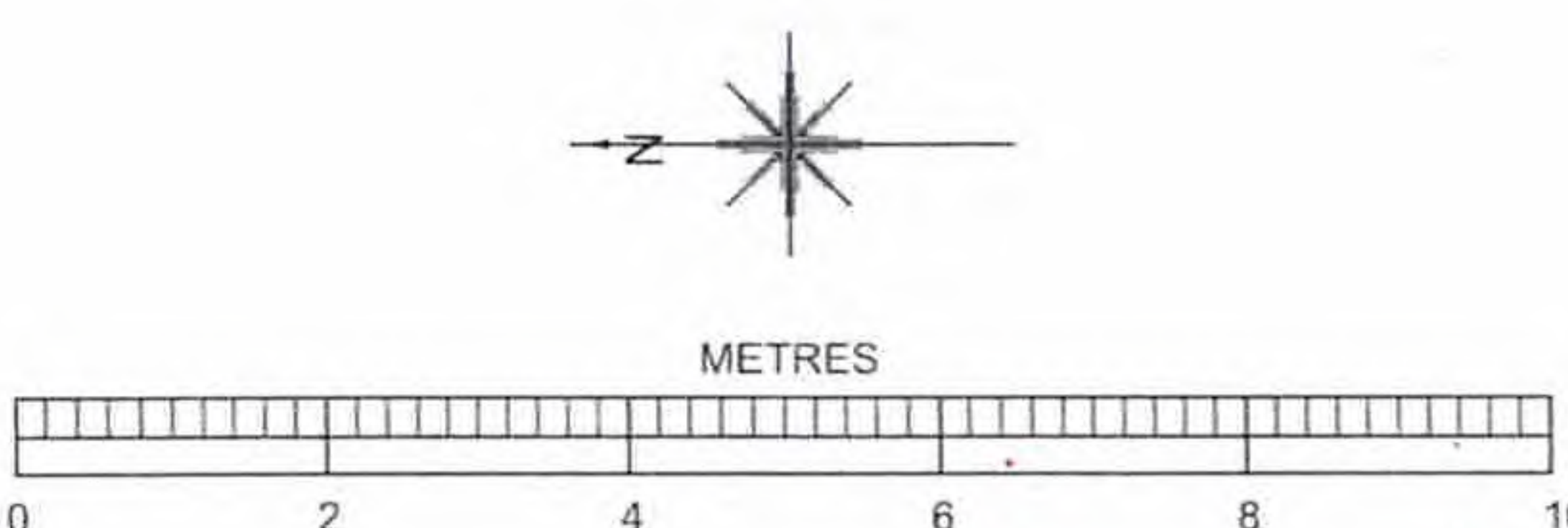
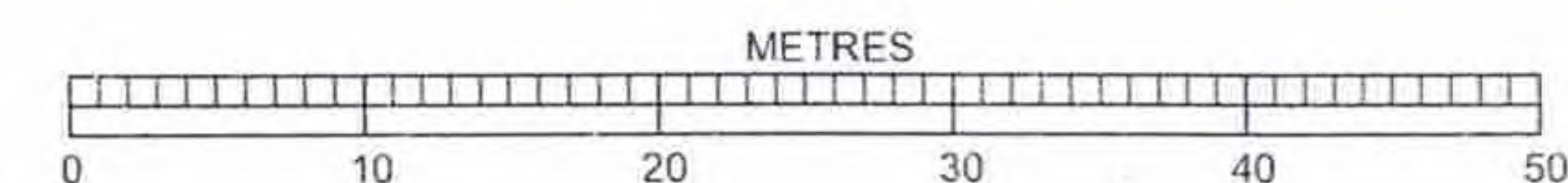
Proposed North Elevation (Closed) Scale 1:100 at A3
