The premises shall install and maintain a comprehensive CCTV system.

All recordings shall be stored for a minimum period of 31 days.

b) The prevention of crime and disorder

Staff will take all reasonable precautions to ensure that people entering the premises are not carrying illegal drugs.

The premises shall maintain a zero tolerance policy in respect of illegal drugs.

Should any person be found in possession of illegal drugs they are to be asked to leave the premises.

The premises licence holder shall have in place a policy for dealing with illegal drugs on the premises.

c) Public safety

Where reasonably practicable, a Personal Licence holder will be present on the premises when a function/event is taking place.

When outside events take place which attract more than 500 persons, the Fire Authority, Police and Licensing Authority shall be given written notice of each event at least 28 days in advance.

The appointment of SIA registered door staff for indoor events shall be risk assessed by the Management of the premises.

At any outdoor event all alcoholic and soft drinks must be served in plastic or toughened glasses.

d) The prevention of public nuisance

When the premises proposes to sell alcohol for consumption on the premises by retail to non-residents at 05:00hrs for major national and international sporting events, 14 days prior notification shall be given in writing to the Police and Licensing Authority.

e) The protection of children from harm

A Challenge 21 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram or other form of ID agreed with the Licensing Authority in writing including approved electronic forms of ID.

 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

- 14. This is the address which we shall use to correspond with you about this application.
- 15. Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be issued to an individual or an individual in a partnership which is not a limited liability partnership who is resident in the UK who:

• does not have the right to live and work in the UK; or

• is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have the right to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

They do this in one of two ways:

- 1) by providing with this application copies or scanned copies of the documents which an applicant has provided, to demonstrate their entitlement to work in the UK (which do not need to be certified) as per information published on gov.uk and in guidance
- 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Home Office online right to work checking service

As an alternative to providing a copy of original documents, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their share code (provided to them upon accessing the service at https://www.gov.uk/prove-right-to-work) which, along with the applicant's date of birth will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be shared digitally. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copies of documents as set out above.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your license application will not be determined until you have complied with this guidance.
