# Wiltshire Children and Young People's Charter for Arts and Culture

The aspiration is that this Charter for Arts and Culture will inspire everyone involved in the delivery of 'arts and culture' with children and young people in Wiltshire, to consistently deliver, high quality opportunities which lead to high quality outcomes related to creativity, art work, culture, learning, personal, social and skill development.

## This charter seeks to encourage and promote:

- The sharing of information from key organisations, in Wiltshire and nationally, about their approach to arts and cultural provision for children and young people and specifically their perspective of 'good quality' provision.
- Professional and organisational development through the sharing and analysis of practice by individuals and organisations to improve outcomes for children and young people engaging in arts and cultural activities.
- Sharing of information about sources of support for the development of arts and cultural work with young people.
- Reflection on practice against a common standard.
- Organisations engaging young people in arts and cultural experiences to work to a shared quality framework, which is dynamic and reviewed at regular intervals.
- Sharing examples of good quality 'Arts and Culture' work which have taken place with children and young people.
- Advocacy for the importance of 'arts and cultural activities' to children and young people based on evidence of the positive impact through 'case studies'.
