

New Roads and Street Works Act 1991
Section 58 Notice of Substantial Road Works

1. Three months advance notice is hereby given that Wiltshire Council intends to carry out substantial road works.
2. The street in which these works will take place is: B3107 The Street, Holt and The Midlands, Holt. The work is expected to affect the entire Footway of the street as per the attached drawing: (B3107 The Street and The Midlands, Holt Site Extents).
3. Work is expected to commence on 5 January 2018 and the restriction will come into force on the 9 January 2018.
4. The works notified will include the following: footway reconstruction.
5. Subject to the exemptions in the Act and Regulations under it, no road or street works may be executed for a period of five years from completion of the works described in Paragraph 4 without the consent of the said highway authority, which is not to be unreasonably withheld.
