

Application fees

When applying for a licence under the Animal Welfare (Licensing of Activities Involving Animals) (England) Regulations 2018, the applicant must pay the relevant "application fee" shown as the first column of figures, this must be paid at the time of application. This fee covers the cost of administering the application and carrying out one inspection to determine whether a licence can be granted or not.

When the relevant premises has been inspected and a decision is made that a licence can be issued, the officer who has carried out the inspection will also carry out the required assessment of risk which will determine the star rating that will apply to the licence and the length of time the licence will be issued.

If applying for a licence to carry out more than one licensable activity, any additional activity will be charged at 50% of the application fee shown in the table the same calculations will apply to the grant fees.

For example someone applying for a licence to provide Boarding for Cats (up to 10 animals) providing boarding in kennels for dogs (11 to 30 animals) will need to pay:-

New - 1 x application fee £215 (Boarding in Kennels for Dogs) higher fee + 50% of second activity application fee (Boarding for Cats up to 10 animals) 50% of £180 (£90) Total = £305 payable at the point of making the application:

Renewal - 1 x application fee £165 (Boarding in Kennels for Dogs) higher fee + 50% of second activity application fee (Boarding for Cats up to 10 animals) 50% of £135 (£67.50) Total = £232.50 payable at the point of making the application:

And then prior to granting the licence

New - 1 x higher grant fee + 50% lower grant fee shown in the table for the relevant licensable activity (ies), and number of years the licence will be granted / star rated for. Any relevant vet's fees must also be paid at this point.

Renewal - 1 x higher grant fee + 50% lower grant fee shown in the table for the relevant licensable activity (ies), and number of years the licence will be granted / star rated for. Any relevant vet's fees must also be paid at this point.

The grant (licence) fees covers the costs of on-going compliance and enforcement activities, including unannounced inspections. Fees to

apply for a variation of licence

A licence holder may apply to vary their licence, for example to increase the number of animals on their licence or to include a new licensable Activity
