

APPLICATION FOR A PRIVATE HIRE OPERATORS LICENCE

Note: Section 57(3) of the Local Government (Miscellaneous Provisions) Act 1976, provided that; 'If a person knowingly or recklessly makes a false statement or omits any material particular in giving information under this section, he shall be guilty of an offence' and liable on conviction to a fine not exceeding level 3 on the standard scale of maximum fines.

- Criminal Records Bureau Basic Disclosure.
 (Applicants who have resided outside the United Kingdom for more than six months since the age of ten will also be required to supply a certificate of good conduct from the country or countries where they have resided in that time.)
- Right to Licence check
- Wiltshire Council's private hire knowledge guidelines test.
