<p>5 November – 2 December; National Lockdown</p> <p>This grant is called the National Restrictions Support Grant (LRSB) Closed Addendum</p>	<p>Businesses that pay rates or have a rate account and whose premises were shut as a result of national restrictions. This includes non-essential retail, pubs, restaurants and visitor attractions. <p>30 December – 5 January, Tier 3</p> <p>This grant is called the Local Restrictions Support Grant (LRSO) Tier 3</p>	<p>We are awaiting information from Government regarding entitlement to funding for this period.</p> <p>During Tier 3, hospitality and accommodation businesses were fully closed. For this 5 day period, awards will be made to these businesses under the LRSO Closed scheme.</p> <p>An LRSO Open award will be made to other hospitality and leisure businesses affected by restrictions.</p>	<p>LRSO Closed:</p> <p>Rateable value under £15,000: £238</p> <p>Rateable value between £15,000-£51,000: £357</p> <p>Rateable value over £51,000: £537</p> <p>LRSO Open:</p> <p>Rateable value under £15,000: £167</p> <p>Rateable value between £15,000-£51,000: £250</p> <p>Rateable value over £51,000: £375</p>

<p>5 January - 16 February Local Restrictions Closed Addendum and Closed Business Lockdown Payment</p>	<p>The Chancellor has announced additional support for businesses during the lockdown period from 5 January.</p> <p>Businesses eligible for LRSB Closed are eligible for the one-off Closed Business Lockdown Payment. We will make automatic repayment to businesses who have already received LRSB Closed awards.</p> <p>Rated businesses closed by national restrictions will receive a six-week LRSB Closed Addendum Payment and a one-off lump sum as announced by the Chancellor in line with the amounts in the next column.</p> <p>Businesses must apply by 31 March 2021.</p> <p>The chancellor also announced additional discretionary funding which will be combined into the Additional Restrictions Grant below</p>	<p>LRSB Closed Addendum</p> <p>Rateable value under £15,000: £2,001</p> <p>Rateable value between £15,000-£51,000: £3,000</p> <p>Rateable value over £51,000: £4,500</p> <p>Closed Business Lockdown Payment</p> <p>Rateable value under £15,000: £4,000</p> <p>Rateable value between £15,000-£51,000: £6,000</p> <p>Rateable value over £51,000: £9,000</p>
<p>16 February - 31 March Local Restrictions Support Grant Closed Addendum</p>	<p>Funding will be paid to successful LRSB applicants. We are currently awaiting government funding for this period.</p> <p>New applications must be received by 31 May 2021</p> <p>Note: if you have already applied for an LRSB grant, you do not need to apply again. You will be automatically paid for any subsequent LRSB grants you are entitled to.</p>	<p>LRSB Closed Addendum</p> <p>Rateable value under £15,000: £2,096</p> <p>Rateable value between £15,000-£51,000: £3,143</p> <p>Rateable value over £51,000: £4,714</p>

Christmas Support Grants	Pubs that make less than 50% of their sales from food are eligible for this grant. You must be the rate-payer, and meet the following criteria: <ul style="list-style-type: none"> • Freely open to the visiting public (pre-lockdown) • Allowing drinking without food being consumed (pre-lockdown) • Serve drinks from a bar (pre-lockdown) Note: Successful LRSG pubs have been sent application forms; please get in touch if you have not received one.	£1,000 one-off grant The closing date for applications is 28 February.
Nightclubs	Nightclubs are eligible for ongoing support through the LRSG Note: You only need to apply once via the LRSG scheme.	Businesses with a rateable value: Rateable value under £15,000: £667 Rateable value between £15,000-£51,000: £1,000 Rateable value over £51,000: £1,500
Additional Restrictions Grant, also known as Discretionary Payments	If you do not pay rates or your premises has not been closed by restrictions, you may be entitled to discretionary funding. The application window is currently closed but we are anticipating this may re open in April. Please sign up to the newsletter to be notified.	The application window will confirm available amounts.
